State budget update (Julie Walker – State Librarian)

- Legislative session to recess on April 2nd (hopefully).
- There may be changes to TRS, including cuts to the guaranteed pension fund.
- The University System is eliminating supplementary insurance.
- There are several new library directors a training session will be held before this year's ACCG.

- 4.6 Eliminated because it's been addressed in the new funding formula.
- 4.5 Minimum local funding increased to \$500K.
- 4.4 A vote was called for the use of the word "may" (4 votes in favor, 1 opposed).
- 4.7 Add text of current funding formula as an appendix to the document.
- 4.10 Streamlined see changes on draft, page 4.

The Library System Board of Trustees shall provide a plan for the distribution of services to be provided to and/or for each county for each of the State Grants. Additionally, a budget showing the use of the State Grants for the Library System shall be submitted.

Item 14 Eliminated second sentence.

Item 16 Eliminated.

Item 19 Add "requiring appropriate assistance".

"on-line" = "online".

Page 4 Item 20 Add "evaluated <u>at least</u> annually".

Item 24 There will be a bandwidth chart added.

Change "wireless hotspot" to "provides wireless access".

Page 5 Item 25 Add "Devices with <u>productivity</u> software suites".

Change wording to "essential bandwidth" phrase.

Add "evaluated annually".

Beth McIntyre called for a vote on adding the phrase "one library in each county" (5 votes in favor, 2 opposed).

Page 8 "Governing" should not be capitalized (throughout).
